Purpose:

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

1. What is the product?

Type:

Over-the-counter (OTC) derivative contract – FX Forward

Objectives:

The objective of this product is to provide for the exchange, on the **settlement date**, of an agreed amount of one currency for another currency at a pre-agreed FX rate (the **EUR/USD forward rate**). This may be used either to provide protection from adverse movements, or to allow you to benefit from favourable movements, in FX currency rates.

On the **settlement date**, you will pay us USD 1,200,000 (the **USD payment amount**). In return, you will receive EUR 1,000,000 (the **EUR payment amount**). The **EUR payment amount** results from the conversion of the **USD payment amount** into EUR at the agreed **EUR/USD forward rate** of USD 1.2 per EUR 1.

Intended retail Investor:

The product is intended to be offered to retail investors who:

1. want to secure a specific FX rate on a specified date;
2. are able to bear a loss if the FX rate prevailing on the settlement date is below the agreed forward rate;
3. are purchasing the product on an advised basis and/or have knowledge and experience with the product; and
4. have an investment horizon of 12 months.

Term:

The Final Redemption Date of the Product is 12 months (Maturity). The term of the Product is 12 months. The Product provides that if certain extraordinary events occur, you and/or the Counterparty may terminate the Product early. Under certain circumstances, the Product will be terminated automatically. The amount you receive on such extraordinary early termination will be different and may be less than the amount you invested.

2. What are the risks and what can I get in return?

! The risk indicator assumes you keep the product for 12 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less. 4. What are the costs?

A) Costs over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the recommended holding period. They include potential early exit penalties. The figures assume a notional amount of EUR 10.000,-. The figures are estimates and may change in the future.

Recommended holding period:
