**Conditions as regards orders made by E-mail or Fax (if ticked above)**

The client authorizes DenizBank AG to accept and to execute orders placed by the client by e-mail or by fax as an unchangeable document with a valid signature in accordance with the specimen signature deposited with DenizBank AG. DenizBank AG will charge orders to be performed by email or fax according to its price list.

**Overrunning**

Generally, the student account is managed solely on the basis of exhibiting an account balance. An overrunning of the student account is only possible if and insofar as the fees owed by the client are not covered by an existing account balance. When the balance in the student account is exceeded, an overrunning interest will be charged for the exceeded amount and the period of such exceedance. The interest rate for overrunning amounts to 12% per annum (fixed interest rate).

**Interest**

The receivable interest rate of the student account is 0.0% per annum (fixed interest rate).

**Fees and expenses**

DenizBank AG is entitled to charge fees and expenses for its services in accordance with the price list, which is an integral part of this contract (in this context, see section "Contract documents and contract amendments"). For the opening of a student account DenizBank AG charges a non-recurring fee in the amount of € 120.00. For the issuance of balance confirmations to be filed with official bodies a fee in the amount of € 40.00 will be charged for each confirmation. Changes as regards current prices and expenses are subject to sections 44 and 45 of the General Terms and Conditions.
